



SPECIES WITH HUNTING COMPLETELY PROHIBITED

Across Turkey, the following species are completely protected and hunting them is strictly prohibited:

Mammals: Weasel, skunk, badger, stone marten, civet, and island hare.

Birds: Grey heron, taiga bean goose, greylag goose, lesser white-fronted goose, red-breasted goose, greater white-fronted goose, pheasant, water rail, coot, poiraz bird, golden oriole, silver oriole, great cuckoo, white-tailed cuckoo, gamecock bird, little crane, mud crane, spotted crane, corn crane, black redshank, redshank, green sandpiper, pied wagtail, stumpy-tailed gull, lesser black-backed gull, long-tailed gull, great gull, large black-headed gull, black-headed gull, little silver gull, dark-backed gull, Van Lake gull, silver gull, Caspian gull, large dark-backed gull, black-legged gull, curlew, long-tailed curlew, rock pigeon, turtle dove, little turtle dove, desert lark, crested lark, wood lark, skylark, desert wheatear, black-backed wheatear, field pipit, red-backed shrike, woodchat shrike, raven, starling, willow warbler, little sparrow, tree sparrow, yellow-throated sparrow, finch, mountain finch, brambling, grey brambling, chaffinch, cherry finch, eastern cherry finch, red-headed bunting, corn bunting.

In the Aegean Region, specifically in Aydın, hunting of cormorants, jackals, and foxes is prohibited.

HUNTING POLICY

As a facility, the hotel implements a hunting policy to protect wildlife and promote a sustainable future. Through its hunting policy, the hotel aims to contribute to:

- Protecting the natural habitats of wildlife
- Preserving wildlife populations
- Improving the quality of life for wildlife
- Supporting peaceful coexistence between wildlife and humans
- Compliance with the hotel's hunting policy will help reduce the hotel's environmental impact and contribute to a sustainable future.

The hotel's hunting policy includes the following:

- Hunting is strictly prohibited in and around the hotel premises.
- Destroying the natural habitats of wildlife around the hotel is prohibited.
- Causing harm to wild animals around the hotel is prohibited.
- Engaging in behaviors that reduce the quality of life of wild animals around the hotel is prohibited.



WILDLIFE INTERACTION POLICY

Purpose:

The purpose of this policy is to manage the facility's interactions with wildlife and to provide a safe and respectful environment for both wildlife and visitors.

Scope:

This policy applies to all employees and visitors of the facility.

Responsibilities:

- All employees are responsible for conducting their interactions with wildlife in accordance with this policy.
- All visitors are responsible for conducting their interactions with wildlife in accordance with this policy.

Guidelines:

- Do not feed wildlife.
- Do not approach wildlife.
- Do not touch wildlife.
- Do not disturb wildlife nests or young.
- Be careful when photographing wildlife.
- If you encounter any issues regarding wildlife, please report them to local authorities.

The facility will manage its interactions with wildlife by adhering to this policy, ensuring a safe and respectful environment for both wildlife and visitors.

The facility does not engage in trade involving protected species. We do not support hunting-related commerce, nor do we buy or sell wildlife as souvenirs or decorative items.


